This vast, Australian website provides authoritative information about the mental, physical, and emotional health of children and teens. Composed in brief, basic, child-friendly language and formats, students can access information and read it on their own. The articles are designed to raise awareness and deepen understanding of topics related to child health, safety, and well-being. The visuals and illustrations that accompany articles are all created by children, which can appeal to the student audience. Educators can use the resource to locate information to incorporate into lessons and students can explore topics of interest and use the website for research projects.

Materials covered in this online resource support many topics that are progressively developed throughout the K-7 curriculum that educate and support physical, emotional, and mental growth, health, and safety.

For example, when describing Autism the site uses blanket statements that do not address the spectrum of abilities and needs that people with Autism may present with. It could give some information that could give a false representation of the needs of an individual with a disability.

In Australia many of the schools have religious affiliation so some of the content on the website may include religious references. School counsellors can be chaplains, and some content contains references to biblical topics.

Consent is also discussed using Australian law so explanation of Canadian differences would be encouraged. Teachers in British Columbia would want to augment their use of this resource with Canadian content to give students the most access to Canadian resources for support.

The accompanying visuals and illustrations are created by children, so the resource is appealing to the intended audience. With the vast number of topics, there is information that will be of interest to both male and female students.

Comments:

This website has a simple structure that has a straightforward search engine and topics grouped by common themes. The website has active links to some other sites. This is a site that provides a great deal of good information for children in kid-friendly language. It does not have a great deal of technical flash or other components. Graphics are drawings by children, and there is no sound or extra components. The site does not allow for much differentiated learning as there are no settings to adjust for differing-abled users. There are also no save or print functions. The site has no new, updated content since September 24, 2018.

Comments:

The instructional design of this website is basic. The articles are written for a young audience and there is even a section specifically written at an easy-reading level. The purpose of this site is to share information that children have requested topics on, and it gives clear, easy-to-read information. Some of the topics have added games, quizzes, or links, input from readers and from Dr. Kim and Kate which could help learners gain more understanding. Interaction with the material is limited because of the website features. The website doesn't provide ways to demonstrate learning or tools for assessment.

The KidsHealth website covers topics with depth that is appropriate for the cognitive level of elementary age students. The physician-reviewed mental, physical, and emotional health topics can be accessed within specific subheadings such as "Your Feelings", "Your School", "Your Safety", and "Nearly Teens", or sought out by keyword search. The resource mainly supplies information to raise awareness and deepen understanding of any topic related to children's health, safety, and well-being. There are a few external links and limited multimedia opportunities.
